ARTICLE I - NAME

The name of this corporation is Downtown Medical Group, Inc. The principal address of this corporation is 10097 Cleary Blvd., Suite #244, Plantation, FL 33324.

ARTICLE II - DURATION

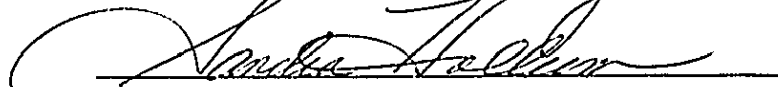
