Pursuant to Section 607.0202, Florida Statutes, these articles of incorporation provide that:

1. The name of the corporation is Phoenix Possibilities Corporation (the "Corporation").
2. The principal office of the Corporation is 203 18th Street N.W., Bradenton, FL 34205.
3. The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of Common Stock, par value \$1.00.


