ARTICLES OF INCORPORATION

OF

ARTICLE I

CORPORATE NAME

The name of this Corporation is D. & L. KITCHEN ART DESIGN, INC.

ARTICLE II

DURATION

This Corporation shall have perpetual existence, and shall commence on the date of the execution and acknowledgment of these Articles of Incorporation.
