ARTICLES OF INCORPORATION

#### SIMEONE & ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation is SIMEONE & ASSOCIATES, INC.

#### ARTICLE II - DURATION

The duration of the corporation is perpetual.

#### ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

- (1) To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.

All stock when issued shall be paid for and shall be nonassessable.
- (2) In the election of directors of this corporation there shall be no cumulative voting of the stock entitled to vote at such election.

#### SRTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial street address of the principal office of this corporation in the State of Florida will be 501 N. Magnolia Avenue, Orlando, Florida 32801. The Board of Directors may from time to time move the principal office to any other address in Florida. The name of the initial registered agent of this corporation is KENNETH D. ## ARTICLE VI - INITIAL BOARD OF DIRECTORS
