The undersigned, in order to form a corporation for the purposes hereinafter stated by and under the provisions of the Statutes of the State of Florida, do hereby subscribe to these articles of -
Incorporation :

1. NAME:

The name of this Corporation is:

NIC'S PRINTING ENTERPRISES, INC.

2. DURATION:

This corporation shall have a perpetual existence.

3. PURPOSE :

This corporation is organized for the following
purposes:

a) Engage and operate a business of sewing, printing
silk screen T Shirts, Caps, sportwear and related activities.

b) To distribute and sell all kind of merchandise and
wares

c) To purchase, sell, lease, operate, own, hold,
transfer, convey, mortgage, or otherwise encumber, trade, exchange
and generally deal in real estate and personal property of every
kind, nature and description whatsoever located, both tangible
and intangible and including choses in action, either as owner,
broker, agent or factor.

d) In the purchase or acquisition of property, business
rights or in or about its business affairs and without limit as
to amount; to incur debts and to raise, borrow and secure the pay-
ment of money in any lawful manner, including the issue and sale
or other entity.

e) To engage in any or all lawful activity and to ins-
titute, participate in and promote commercial, mercantile, finan-
cial and industrial enterprises and operations, and for the purp-

ose of transacting any or all lawful business, both within or without the territory of the United States of America.

4. POWER.

a) This corporation shall have all the corporate - power ennumerated in the Florida General Corporation Act.

5. CAPITAL STOCK:

This corporation is authorized to issue 500 shares common stock, which shall be designated "Common Shares", at a par value of \$1.00 (ONE DOLLAR) per share.

6. PREEMTIVE RIGHTS:

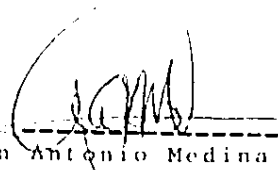
