### ARTICLES OF INCORPORATION

OF

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I

The name of the corporation shall be KENNY FOY FARMS, INC., with its principal office located at 4605 Fort Hamer Road, Parrish, Florida 34219.

### ARTICLE II

The number of shares the corporation is authorized to issue is 1,000 shares.

# ARTICLE III

The steet address of the initial registered office of this corporation shall be 4605 Fort Hamer Road, Parrish, Florida 34219, and the initial registered agent at such address will be KENNETH H. FOY.

# ARTICLE VI

### ARTICLE V

Each shareholder of the corporation shall be entitled to full pre-emptive rights to acquire his or her proportional part of any unissued or treasury shares of the corporation, or securities of the corporation convertible into or carrying a right to subscribe to or acquire shares, which may be issued at any time by the

corporation. But, in no case shall these preemptive rights exist for a period in excess of 30 days from their first being offered to the shareholders.
