ARTICLES OF INCORPORATION  
OF  
WETCUTS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Article of Incorporation for the purpose of organizing a business corporation.

ARTICLE 1

The name of the corporation ("Corporation") is WETCUTS, INC.

ARTICLE 2

The existence of the corporation shall begin immediately effective upon the acceptance of these Articles of Incorporation by the Florida Secretary of State.

ARTICLE 3

The address of the principal office of the Corporation is 106 S. MacDill Ave., Tampa, Florida 33609.

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares. 

ARTICLE 7


The corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.
