ARTICLES OF INCORPORATION

of

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I
Corporate Name

The name of this Corporation is: Associated Promotions, Inc.
