ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS ECUADORIAN CARGO, INC.

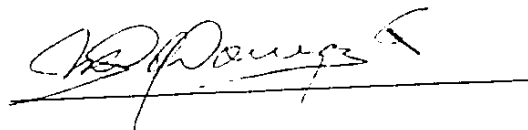

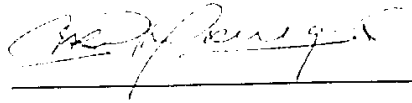
