The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Article of Incorporation:

ARTICLE I - NAME

The name of this corporation is R & M Car Care, Inc. The mailing address is 108 N. Parsons Ave., Brandon, FL 33510

ARTICLE II - DURATION

This corporation shall have a perpetual existence, commencing on the date of July 1, 1995.

ARTICLE III - PURPOSES
