ARTICLES OF INCORPORATION CORPORATE PARK AT WESTON ASSOCIATES, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida:

- The name of this corporation and the mailing address of the NAME corporation are: CORPORATE PARK AT WESTON ASSOCIATES, INC., 600 Corporate Drive, Suite 512, Fort Lauderoale, Florida 33334.
- PURPOSE The corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the State of Florida.
- CAPITAL STOCK This corporation is authorized to issue One Thousand (1,000) shares of One (\$1.00) Dollar par value common stock, which shall be designated as "Common Shares." All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof at a just valuation to be fixed by the Board of Directors.
