- 2. The existing Article IV is deleted in its entirety. A new Article IV is inserted which provides as follows:

"The aggregate number of shares which this corporation is authorized to issue is one million (1,000,000) shares of common stock (designated as "common shares") having a par value of one dollar (\$1.00) per share."

- Article V Initial Registered Agent and Office:
 The registered office and mailing address will be changed from "3491 Pall Mall Drive, Suite 102, Jacksonville, Florida 32257 to "3000-6 Hartley Road, Jacksonville, Florida 32257."
- 4. The foregoing amendment was adopted in accordance with Florida Statutes, Section 607.074 on the 28th day of March, 1996 by written consent of Stockholders of the corporation. The written consents of stockholders in such voting group were sufficient for approval by that voting group.
