ARTICLES OF INCORPORATION

OF

RONCAR ENTERPRISES, INC.

ARTICLE I - NAME

The name of this corporation is RONCAR ENTERPRISES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS


