OF

ARTICLE I - NAME

The name of this corporation is RONCAR ENTERPRISES, INC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the corporation is: 30394 Old Dixie Highway, Homestead, Florida 33030.

ARTICLE III - DURATION

This corporation shall have perpetual existence, commencing upon the 29 day of June, 1995, being the same date as the subscription to and acknowledgment of these Articles of Incorporation.

ARTICLE IV - PURPOSE

This corporation is formed for the purpose of transacting any and all lawful business not specifically prohibited by applicable Florida law.

ARTICLE V - CAPITAL STOCK



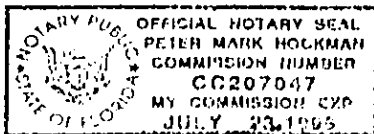
