ARTICLES OF INCORPORATION

THE UNDERSIGNED, RODNEY J. TROYER, hereby executes this document for the purposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following proposed Cortificate of Incorporation:

ARTICLE I

The name of this Corporation is TROYER BATH SYSTEMS CORPORATION.

ARTICLE II

The general nature of the business to be transacted by the Corporation is as follows:

The Corporation may engage in any activity or business permitted by the Laws of the United States and of this State.

ARTICLE III

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time is Ten Thousand (10,000) shares of common stock of the same class and at ONE DOLLAR (\$1.00) par value.

ARTICLE IV
