ARTICLES OF INCORPORATION

The undersigned Incorporators subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: MANATEE SALVAGE, INC., and its initial mailing address shall be: 108 25th Street West, Bradenton, Florida 34205. The initial address of the Corporation's principal office shall be: 108 25th Street West, Bradenton, Florida 34205.
