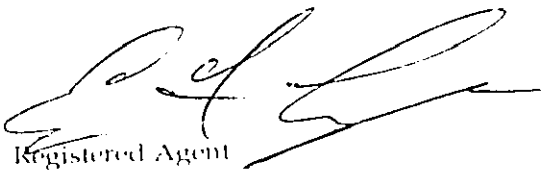
1. The name of the corporation is THIRD WORLD EXCAVATING, INC.

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

1. The name of the corporation is Third World Excavating, Inc..
