

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation.

Article I

NAME

The name of the Corporation is Enricke Industries USA, Inc. and the principal address shall be

DURATION

The corporation shall exist perpetually. Corporate existence shall commence upon filing by the Department of State.

NATURE OF BUSINESS




