The undersigned, for the purpose of forming a corporation under the Florida Ceneral Corporation Act, do hereby adopt the following Articles of Incorporation:

JULY 01, 1995

ARTICLE ONE

The name of the corporation is SPECIAL "T" LIGHTING DESIGNS, INC.

ARTICLE TWO

The duration of the corporation is perpetual. The date and time of the commencement of corporate existence is July 1, 1395.
