ARTICLE I

NAME

THE NAME OF THIS CORPORATION IS GREAT SOUTHERN IMPORT-EXPORT, CORP. and the mailing address is 1745 Sans Souci Blvd. #203, North Miami, Florida 33181.

ARTICLE II

DURATION

This corporation shall have a perpetual existence, unless dissolved according to law.

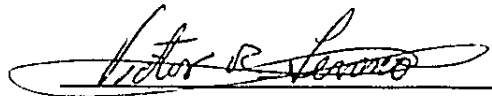

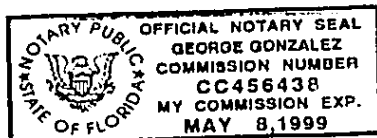
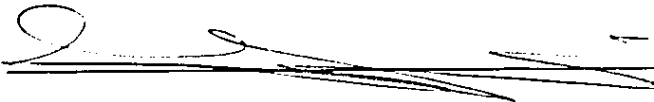
