The undersigned,, for the purpose of forming a corporation under the Florida General Act hereby adopt the following Articles of Incorporation.

The general nature of the business and the objects and purposes to be transacted and carried on are: To do any and all legal business allowed by the laws of the State of Florida and of the United States.

The amount of capital with which this corporation may commence business is \$100.00.

ARTICLE_V

Address

The principal place of business of said Corporation shall be at 1029 South Edgewood Avenue, Jacksonville, Florida, with branches at such other place or places within or without the State of Florida, or within or without the United States of America, as the Board of Directors may from time to time determine and resolve.
