The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation shall be:

P&C Adjustment Services, Inc.

**ARTICLE II**

The principal place of business and mailing address for this corporation shall be:

22251 Woodspring Dr.  
Boca Raton, Fl. 33428

**ARTICLE III**

The period of the duration of this corporation shall be perpetual.

**ARTICLE IV**

The number of the shares of stock that this corporation is authorized to have outstanding at any one time is 100,000, and the common par value of such stock shall be \$1.00 per share. The minimum amount of consideration to be received by the Corporation for its shares before it shall commence business, is Two Hundred and 00/100 Dollars (200.00) in cash or property of equivalent value.

**ARTICLE V**

The purposes for which the corporation is organized are:

- A. To operate an insurance adjustment firm.

- B. To offer a wide variety of insurance related services, including but not limited to, property and casualty claim adjustments, appraisals, valuations, estimations, inspections, and risk management services. These services may be offered to insurance companies, real estate firms, banks, mortgage lenders, or any other financial institution upon request.
- C. To lend and advance money or give credit to such persons, firms and corporations under such terms as may seem expedient, and otherwise deal in stocks and bonds, conditional sales contracts and mortgages of all kinds; to borrow money, to make and issue promissory notes, bonds, bills of exchange, obligations and evidences of indebtedness of all kinds whether secured by mortgage, pledge, or otherwise, without limit as to amount.
- D. To buy, form, or otherwise acquire any other enterprise adapted to be carried on in connection with the Corporation's principal business, together with the good will, rights, property and assets of all kinds thereto pertaining and in connection therewith to assume any of the liabilities of any person, firm, or corporation and to pay for the same in cash, services, stock, or other securities of the Corporation.
- E. To engage in, conduct and operate any other business which may be deemed adapted, directly or indirectly, to add to the profits of its principal business or to increase the value of its property.
- F. In addition to those purposes enumerated above, the Corporation is authorized to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporations Act.

#### ARTICLE VI

The address of the initial registered office of the Corporation is: 22251 Woodspring Dr., Boca Raton, Fl. 33428, and the name of the initial registered agent at such address is Jon Patrick Owen.

#### ARTICLE VII

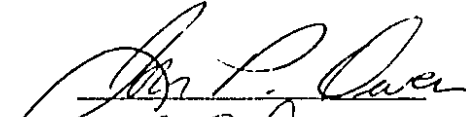

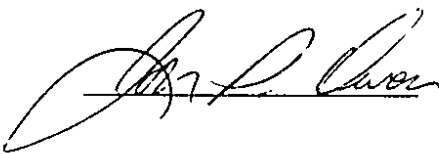

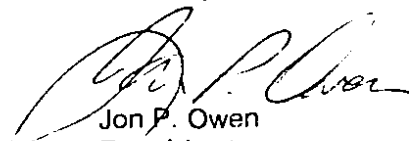
