ARTICLES OF INCORPORATION

ARTICLE I-NAME

The name of this Corporation shall MCMILLAN, STRYKER & ASSOCIATES, INC.

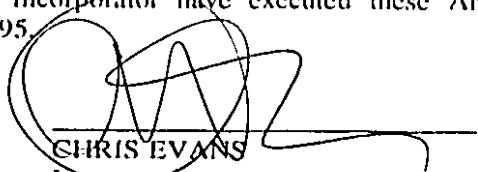
ARTICLE IX-INDEMNIFICATION
