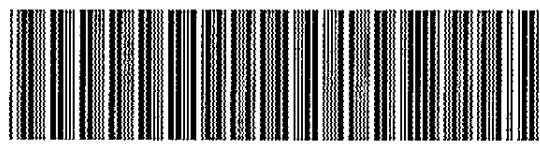

Pursuant to Section 607.1006 of the Florida Statutes, SARILING ATIN IMPORTS, INC., a corporation organized and existing under and by virtue of the laws of the State of Florida (the "Corporation"), does hereby certify:


- FIRST:** Name. The name of the Corporation is Sariling Atin Imports, Inc.
- SECOND:** Amendments Adopted. The amendment adopted provides for the Corporation to change its name from Sariling Atin Imports, Inc. to Blue Paty, Inc.
- THIRD:** Text of Amendments. Article I is hereby amended by deleting such Article I and substituting the following new Article I which reads as follows:

Article I

The name of the Corporation is Blue Paty, Inc.

- FOURTH:** Adoption of Amendments. The foregoing amendment was approved by unanimous written consent of the shareholders and Board of Directors of the Corporation pursuant to Sections 607.0704 and 607.0821, Florida Statutes, on December 27, 2002. The number of votes cast for the approval and adoption of this amendment was sufficient for approval.
- FIFTH:** Effective Date. The effective date of the amendments herein certified shall be the date of filing these Articles of Amendment to Articles of Incorporation with the Florida Secretary of State.
