ARTICLES OF INCORPORATION OF TODAY'S CHILD CREATIVE ARTS PRESCHOOL, INC.

ARTICLE I Namo

The name of the corporation is TODAY'S CHILD CREATIVE ARTS PRESCHOOL, INC.

ARTICLE II Duration

The duration of the corporation shall be perpetual.
