ARTICLE IV - PURPOSE

The purpose of this corporation shall be to provide for the protection of the interests of the citizens of the State of Florida in the event of a nuclear attack on the State of Florida.

Section 1. The name of the corporation is:

ARTICLE V - CAPITAL

SECTION 1. The corporation may exercise the transaction of any and all lawful activities, business, for which corporation may be incorporated and permitted under the laws of the United States and of the State of Florida.

SECTION 2. The corporation may issue shares of stock. That the corporation is authorized to issue a share having par value of One Dollar and one-eighth of a cent, and may not issue shares of One Dollar and one-eighth of a cent.

SECTION 3. The principal address of the initial registered office of the corporation is 22745 S. FEDERAL HWY. SUITE 600, FLORIDA 33170, and the name of the initial registered agent at such address for the corporation shall be ELLING NARHO. This is also the principal office and mailing address of the corporation.

SECTION 4. The number of directors constituting the initial Board of Directors is THREE. The number of directors may be increased or decreased by the corporation's BY-Laws.

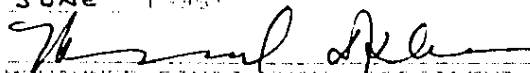

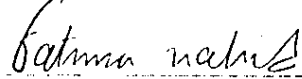

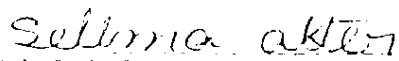
