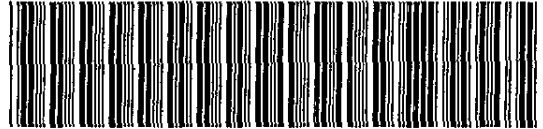

Pursuant to the provisions of Section 621.13, Florida Statutes, the undersigned corporation, as executed by its President and Secretary and acknowledged by its Secretary, hereby executes these Articles of Amendment as follows:

A. The name of the corporation is WEST BROWARD GASTROENTEROLOGY ASSOCIATES, P.A.

B. The Amendment as duly adopted is as follows:


