ARTICLES OF INCORPORATION

OF

GULF COAST COLLECTORS, INC.

ARTICLE I. NAME

The name of the corporation is GULF COAST COLLECTORS, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the filing of these articles with the Department of State.

ARTICLE III. CAPITAL STOCK
