The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

MARIO'S ICE CREAM, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is retail food service, and to engage in every and any aspect and phase of any and every lawful business, including, but not limited to, the following activities:
