ARTICLE I - CORPORATE NAME

ARTICLE II - NATURE OF CORPORATE BUSINESS

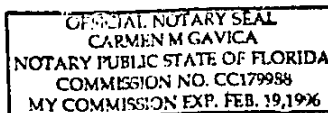
