ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Article of Incorporation:

ARTICLE I

Name

The name of this corporation is: GREY MEDICAL ENTERPRISES, INC.

ARTICLE II

Term of Existence

This corporation shall have perpetual existence.

ARTICLE III

Purposes

The corporation may engage in the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

General Powers

The corporation shall have power:

(a) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated.

(b) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of

all or part of its assets.

(c) To be a promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust or other enterprise.

(d) To have and exercise all powers necessary or convenient to effect its purposes permitted under the laws of the State of Florida.

ARTICLE V

Capital Stock

The total number of shares of capital stock authorized to be issued by the corporation shall be 100 shares having no par value. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services at a fair valuation to be fixed by the shareholders at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.

ARTICLE VI

Registered Agent and Initial Registered Office

The Registered Agent and the street address of the initial registered office of the corporation in the State of Florida shall be: LAWRENCE F. GREY, M.D., 4600 N. Habana Avenue, #28, Tampa, FL 33614.

ARTICLE VII

Principal Office and Mailing Address

The principal office of this Corporation and its mailing

ARTICLE VIII

Management

The affairs of this corporation shall be managed by its shareholders and officers. The corporation shall have no directors.

Incorporator



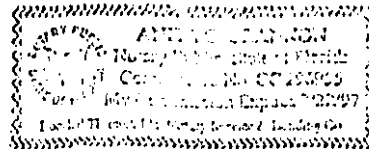
