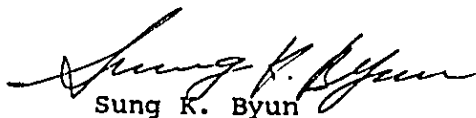

CORPORATE NAME

The name of this corporation is MR. B JEWELRY, INC.

ARTICLE II
PURPOSE

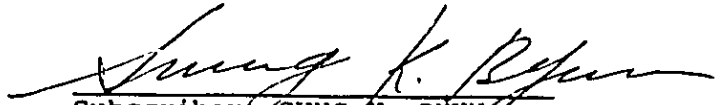

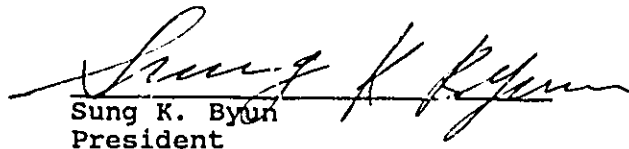

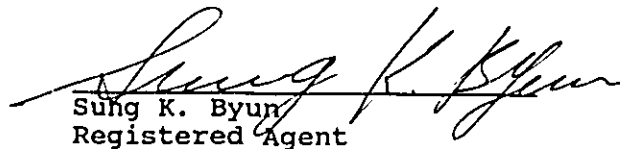
