# ARTICLES OF INCORPORATION

OF

## **NOCATEE LIQUOR COMPANY**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation:

## **ARTICLE ONE**

#### NAME

The name of the corporation is NOCATEE LIQUOR COMPANY.

## **ARTICLE TWO**

#### **DURATION**

The term of existence of the corporation shall be perpetual.

# ARTICLE THREE

# **PURPOSE**

The purpose for which the corporation is organized is to engage in any activities or business permitted under the laws of the United States and Florida.

# **ARTICLE FOUR**

#### CAPITAL STOCK

The aggregate number of shares which the corporation has authority to issue

is 1000 shares, all of which shall be common shares with a par value of \$1.00.

#### **ARTICLE FIVE**

#### PREEMPTIVE RIGHTS GRANTED

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation with thirty (30) days of receipt of notice from the corporation.

## **ARTICLE SIX**

#### REGISTERED OFFICE AND AGENT AND PRINCIPAL OFFICE

The name and address of the initial registered agent of this corporation shall be Barry K. Raineri, Arcadia, Florida 33821. The registered office of this corporation is 207 E.
