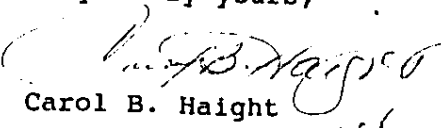

NAME, ADDRESS OF CORPORATION AND INCORPORATOR

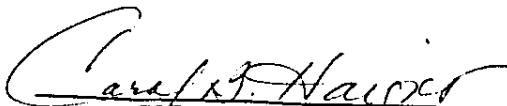
