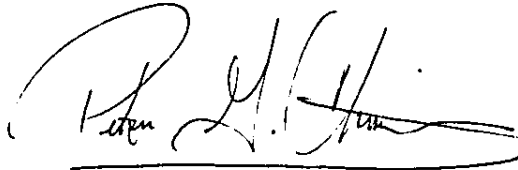
#### Article IX
