# ARTICLES OF INCORPORALLAHASSEE.FLORIDA

BOWEN & CALDWELL BUSINESS SERVICES. INCORPORATED

#### ARTICLE I - NAME

The name of the corporation is: BOWEN & CALDWELL BUSINESS SERVICES, INCORPORATED.

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these Articles of Incorporation with the Secretary of State of the State of Florida.

# ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business, including, but not limited to, the preparation of accounting and tax documents.

# ARTICLE IV - CAPITAL STOCK

#### ARTICLE XV - AMENDMENT

The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the Shareholders is subject to this reservation.

# ARTICLE XVI - RESTRICTIONS OF TRANSFER OF STOCK

Shares of capital stock of this corporation shall be issued initially to the following persons in the amount set forth opposite the name:
