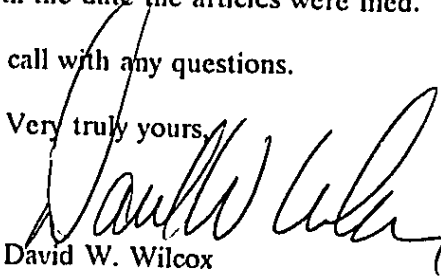

**ARTICLE 1 - NAME/ADDRESS**

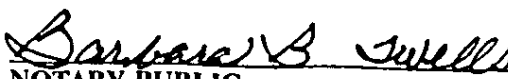
