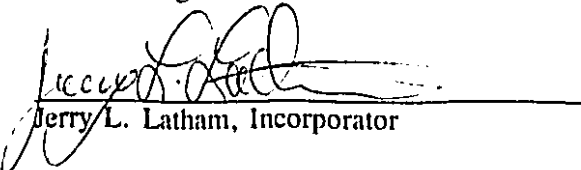
ARTICLE VII INDEMNIFICATION
