ARTICLES OF INCORPORATION
OF

AMERICAN INTERNATIONAL CONSTRUCTION CORPORATION

The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is AMERICAN INTERNATIONAL CONSTRUCTION CORPORATION.

ARTICLE II. DURATION

The corporation shall have perpetual existence.

ARTICLE III. PURPOSE

the corporation shall have the power, privilege and right to engage in any activity or business permitted under the Laws of United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of \$1.00 par value common stock.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII. MANAGEMENT OF CORPORATION BY SHAREHOLDERS

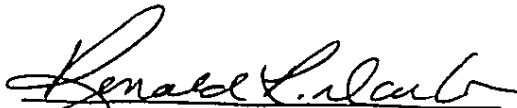

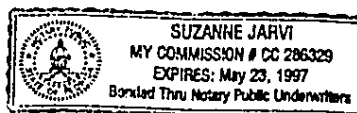
