ARTICLES OF INCORPORATION

OF

BLEEDING EDGE COMPUTING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**Article 1: Name.** The name of the Corporation is BLEEDING EDGE COMPUTING, INC.

**Article 2: Duration.** The duration of the Corporation is perpetual.

**Article 3: Purpose.** The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

**Article 4: Capital Stock.** The Aggregate number of Shares which the Corporation is authorized to issue is 1000 (One Thousand) shares of common stock. Such shares shall be of a single class and shall have a par value of One Dollar per share. The initial Shareholders are Ron Lay, who holds 500 shares, and Chelsea Carlstedt, who holds 500 shares.

**Article 5: Principal Office, Initial Registered Office, and Agent.** The street address of the principal office and initial registered office of the Corporation is 1960 Stickney Point Road, Suite 210, Sarasota, Florida, 34233, and the name of the initial Registered Agent at that address is Ron Lay.

**Article 6: Initial Board of Directors.** The number of Directors constituting the initial board of Directors is Five. The number of Directors may be increased or decreased from time to time in accordance with the bylaws but shall never be less than One. The names and addresses of the initial directors of the Corporation are as follows: Chelsea Carlstedt, President; Ron Lay, Vice President, and Secretary/Treasurer; Dave Bothe, Director; Jerry Peterson, Director; and Andrew Scherman, Director; all of 1960 Stickney Point Road, Suite 210, Sarasota, Florida. 34231.

**Article 7: Incorporator.** The name and address of the incorporator is Ron Lay, 1960 Stickney Point Road, Suite 210, Sarasota, Florida, 34231.

**Article 8: Amendment.** The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

**Article 9: Indemnification.** The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

**Article 10: Bylaws.** The power to adopt, alter, amend, and repeal Bylaws shall be vested in the Board of Directors, but all alterations, amendments, and repeals of the Bylaws must be approved by a majority of the Shareholders.

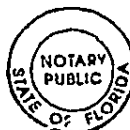
