## ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I

NAME: The name of the corporation is FRANCINE THURMAN, COURT REPORTER, INC.

#### ARTICLE II
