FOR

Article I

The name of the corporation shall be Frog Saver Enterprises, Inc.

Article II

The principal place of business and mailing address for the corporation shall be 16 Andromeda Drive, Milton, Florida 32570.

Article III

The corporation shall be authorized to issue initially up to one-thousand (1,000) shares of stock, and the initial class of stock will be limited to common stock with a par value of \$1.00 per share.

Article IV

The initial shareholder, holder of one-hundred (100) shares, will be Jeffrey A. Parr, who will hold pre-emptive rights to those shares and to the remaining unissued nine-hundred (900) shares, subject to modification as authorized by law.

The name and address of the initial registered agent is: Jeffrey A. Parr, 16 Andromeda Drive, Milton, Florida 32570.


Article VI
