ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation is RUSSELL'S ALUMINUM OF LAKE & SUMTER COUNTIES, INC.

ARTICLE II. DURATION

This corporation shall begin its existence on the 13th day of July, 1995.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.
