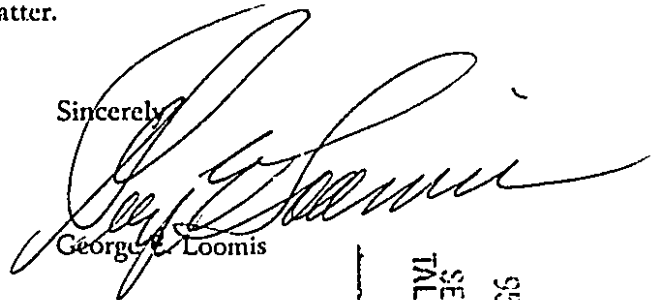

NAME**

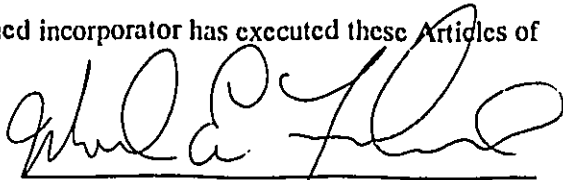
**ARTICLE VIII.
