Article I - Name

The name of this corporation is C. King, Inc. and the initial office of the corporation shall be located at 29-B Miracle Strip Parkway, Fort Walton Beach, Florida, 32548.

Article II - Duration

This corporation shall exist perpetually, commencing with the date of execution and acknowledgment of these Articles.

Article III - Purpose

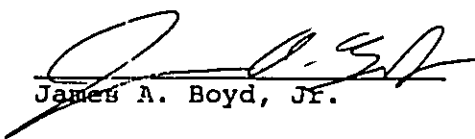
Article X - Indemnification

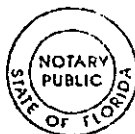

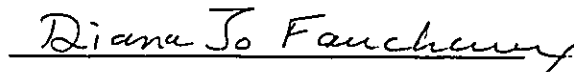

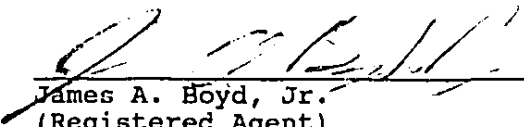
