

ARTICLES OF INCORPORATION

OF

S L BAKERY, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE I: The name of the corporation is:

S L BAKERY, INC.

ARTICLE II: The duration of the corporation is perpetual.


ARTICLE III: The purposes for which the corporation is organized are:

- A. To carry on and transact any lawful business.
- B. To acquire, own, use, convey, and otherwise dispose of and deal in real property, and other personal property or any interest therein.
- C. To enter into any lawful arrangements for sharing profits and losses in any transaction or transactions.

ARTICLE IV: The corporation may issue FIVE HUNDRED (500) shares of voting common stock of par value ONE DOLLAR (\$1.00) each share with preemptive rights preserved.





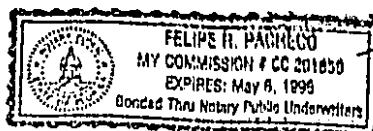
