ARTICLES OF INCORPORATION
OF

The Undersigned, acting as incorporator(s) of a corporation under the Florida General Corporation Act, adopt the following articles of incorporation for such corporation:

1. The name of the corporation is J & P PERSONAL PUTTERS, INC. and the initial principal address of the corporation is 848 South Bay Street, Eustis, Florida 32726.
2. The period of its duration is perpetual. The corporate existence of the corporation shall commence upon the filing of these Articles of Incorporation with the Secretary of State of the State of Florida.


