**ARTICLE I NAME**

The name of the corporation shall be: EWELL, YOUNG & ASSOCIATES, INC.

**ARTICLE II PRINCIPAL OFFICE**

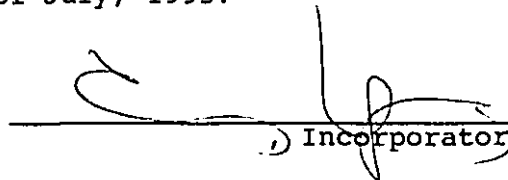

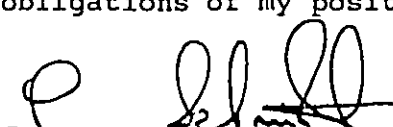
