The undersigned subscriber to these and of incorporation being duly licensed to practice real estate under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION:

The name of the professional service corporation is MOSES L. SALCIDO, P.A.

ARTICLE II

PRINCIPAL OFFICE:

The principal office and mailing address of this corporation are: 2301 Cherrywood Lane, Orlando, Florida 32803.

ARTICLE III

PURPOSE:


