Pursuant to Sections 607.1001 and 607.1002 of the Florida Business Corporation Act (the "Act"), TOTAL THERAPEUTIC MANAGEMENT, INC., a Florida corporation, hereby submits these Articles of Amendment:

1. The name of the corporation is:
"Total Therapeutic Management, Inc."
2. The Articles of Incorporation of the Corporation are hereby amended by deleting the present Article III in its entirety and substituting the following in lieu thereof:

ARTICLE III SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is

1,000,000 (1 million shares)

which do not have a par value.

3. The foregoing Amendment was duly adopted by the Board of Directors of the Corporation as of April 3, 2000, without shareholder action.
